1. Purpose and Scope

This document sets out the conditions for the use of the AQRATE verification logo. The Measured Enterprise may use the AQRATE verification logo awarded. The conditions contained in this document shall be met by all AQRATE's B-BBEE verified companies.

2. General format and display of AQRATE verification logo.

2.1 The AQRATE corporate logo displayed on page 1 of this document is only for AQRATE use and may not be used by any other organisation.

2.2 The Verification logo awarded may only be used once a B-BBEE Verification Certificate has been issued..

2.3 A B-BBEE verified Measured Enterprise (client) of AQRATE is entitled to display the AQRATE verification logo awarded to it on its stationery (e.g. Letterheads, Quotations, and Brochures).

3. Use of the AQRATE verification logo in publicity material

3.1 Verified organisations are entitled to make general reference to AQRATE provided that they ensure that an AQRATE B-BBEE verification is not implied for non-verified activities.

3.2 The AQRATE verification logo shall not be used in literature relating to a product unless it is directly located adjacent to the reference.

3.3 Approval for the use of the AQRATE verification logo in publicity material relating to a product must be obtained from AQRATE.

4. Other restrictions on use of the AQRATE verification logo and certificate

4.1 Subject to conditions stated in this document, the use of the AQRATE verification logo on items other than sheets of stationery is not discouraged, but shall be subject to agreement by AQRATE.

4.2 A verified organisation shall upon suspension of AQRATE immediately cease displaying the AQRATE verification logo.

4.3 AQRATE shall take action to deal with incorrect usage of any of the AQRATE verified logos and or certificate. This action may include:

- request for corrective actions;
- withdrawal of certificates/ reports and B-BBEE Status
- legal action
